Situated on a quiet no through road is this rarely available detached bungalow nestled within the heart of the highly sought after village of Wootton. The home boasts well designed spacious living accommodation that includes three bedrooms and large reception rooms. Externally the home features a driveway with parking for two cars along with a detached double garage. To the rear of the property is a generous enclosed garden with a patio area that offers the ideal space for outdoor entertaining and artificial grass laid for low maintenance.

Entering the home through the front door you are greeted by a welcoming hall with in built storage and doors opening on to all of the living accommodation. Wootton is a large village situated to the South-West of Bedford, which is ideally placed for the A421 bypass which links the A1, M1 and A6. The village offers an array of amenities including three small supermarkets one being a Tesco express, Doctors surgery, dentist, hair salon, Legstraps restaurant, plus five further pubs/restaurants. There are local sports clubs plus pre-school, Primary and Secondary schooling. There is a regular bus service into Bedford. There is also numerous Countryside walks surrounding the village.

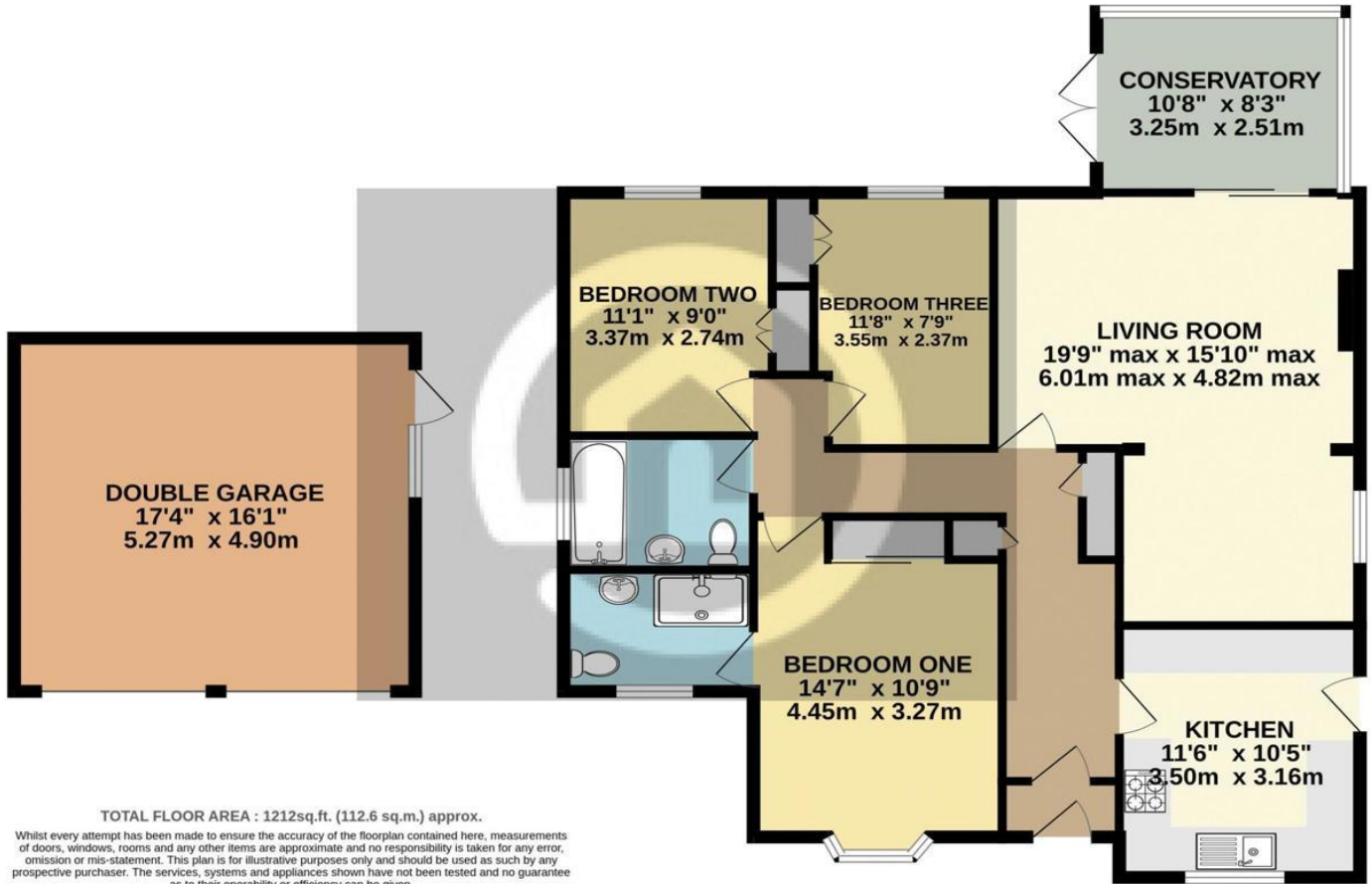
